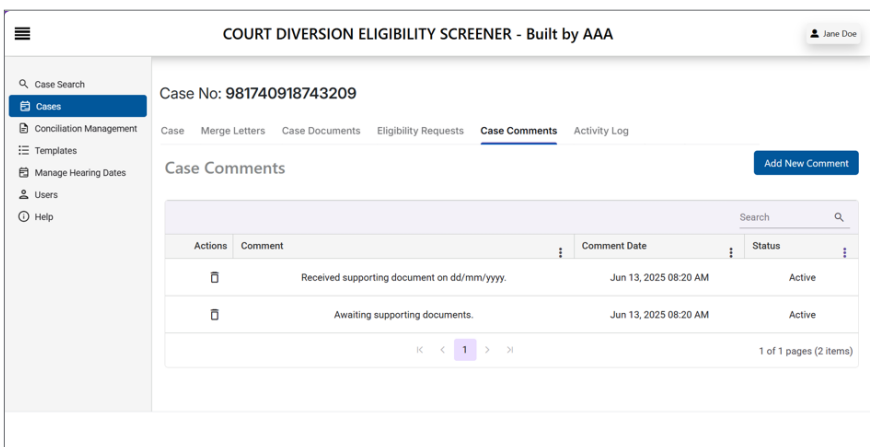
The Problem Court Diversion Eligibility Screener Solves

How Court Diversion Eligibility Screener Works

3. **Schedule conciliation conference.**
4. **Use the AI Check Eligibility feature to confirm diversion eligibility.** The platform automatically analyzes uploaded documents against predetermined criteria.
5. **Generate Case Management Order using templates.** The system auto-fills key fields like case caption and hearing date.
6. **Run AI eligibility re-check** as additional documents are submitted.
7. **Hold conciliation conference.** Access a list of all cases scheduled for a hearing day.
8. **Generate additional orders** using templates as needed to record outcome.
