AAA-ICDR® President and CEO Bridget McCormack Elected to the American Law Institute Council

NEW YORK (May 23, 2024)— The American Arbitration Association® (AAA®) is proud to announce that Bridget McCormack, president and CEO of the American Arbitration Association-International Centre for Dispute Resolution® (AAA-ICDR®), has been elected to the Council of the American Law Institute (ALI). The election occurred at ALI’s annual meeting in San Francisco, where six distinguished new members were elected to the Council.

McCormack brings a wealth of experience and a distinguished career to the Council. Before joining the AAA-ICDR in 2023, McCormack served as the chief justice of the Michigan Supreme Court, a position to which her peers elected her in January 2019 after six years as an associate justice. Throughout her tenure, she championed innovation and the use of technology to improve access to justice. McCormack is also a strategic advisor to the Future of the Profession Initiative at the University of Pennsylvania Carey Law School.

“I’m honored to join the ALI Council and look forward to contributing to its important work shaping the future of law,” McCormack said. “The ALI’s mission to clarify and improve the law is more important than ever.”
